

## ADA Trustee Dr. Chad Gehani Receives Prestigious Ellis Island Medal of Honor



Former Queens County Dental Society President Dr. Chad P. Gehani, an American Dental Association trustee, was awarded The Ellis Island Medal of Honor by The National Ethnic Coalition of Organizations last month.

The medal honors individuals who have made it their mission to share with those less fortunate their wealth of knowledge, indomitable courage, boundless compassion, unique talents and selfless generosity, all while maintaining the traditions of

their ethnic heritage as they embody "The American Dream."

Both the U.S. Senate and House of Representatives have officially passed resolutions recognizing the Ellis Island Medals of Honor, which ranks among this country's most prestigious awards. Each year, Ellis Island Medal of Honor recipients are listed in the Congressional Record, honoring those who have made enduring contributions to our nation and the world.

Dr. Gehani was elected as an American Dental Association trustee for the 13th District in 2014. He has been a clinical associate professor at New York University College of

Dentistry for the past 33 years. He was formerly the President of the New York State Dental Association and the Indian Dental Association, as well as QCDS.

Dr. Gehani is also a Trustee of The New York State Dental Foundation. The Foundation is very active in advocating for the oral health of underprivileged New Yorkers, as well as promoting research and oral health education. Some of its projects include "Give Kids a Smile" and the "Missions of Mercy."

He has been honored with a Fellowship by the American College of Dentists, the International College of Dentists and the Pierre Fauchard Academy. In 2000, he was recognized for his contributions to the International Dental Community for his volunteerism and teaching in many countries in South Asia by the International College of Dentists. He has also been a recipient of the "Best Teacher Award" from the International College of Dentists.

When asked for his feelings on receiving the Ellis Island Medal of Honor, he said: "As I travel around the world teaching dentistry and helping impoverished people, each time I return I thank God that I am an American, in a country that allows us to realize the American Dream. I am a very proud American who was made in India. I feel very honored and privileged to receive this award."

Dr. Gehani also maintains a private dental practice at 35-40 82nd Street, Jackson Heights.

## Medicare and Dentistry: Implications and Clarifications

Medicare is a federal health insurance program for people 65 or older. Certain younger people with specific disabilities may also qualify for Medicare. As it stands, Medicare services have been separated into the following parts: Parts A, B, C, and D.

**Medicare Part A (Hospital Insurance):** Covers in-patient hospital care, care in a skilled nursing facility, hospice care, and some home health care.

**Medicare Part B:** Covers certain doctor services, outpatient care, medical supplies, lab tests, imaging serv-

ices, mental health, etc. Enrollees pay a monthly fee for this coverage.

**Medicare Part D (D for drugs):** Provides outpatient prescription drug coverage. With very few exceptions, part D is provided only through private insurance companies that have contracts with the government. It is never provided directly by the government (unlike parts A and B)

**Medicare Part C (Medicare Advantage Plans):** This is not a separate benefit. Part C is the part of Medicare policy that allows private health insurance companies to provide Medicare

benefits. These private Medicare health plans, such as PPOs and HMOs, are known as Medicare Advantage Plans. Many different Medicare Advantage Plans are available.

Centers for Medicare and Medicaid Services (CMS) through Medicare, Medicaid, the CHIP, and The Health Insurance Marketplace covers over 100,000 people in the United States. The Affordable Care Act requires physicians, dentists, and other non-physician practitioners to enroll in the Medicare program to order or refer

Concern About Mid-Level Providers

Mid-Level Dental Providers

Many of us have been paying close attention to potential changes involving mid-level dental providers. I would like to provide you the following update from our ADA Trustee, Dr. Chad Gehani, on where things stand nationally on this issue:

"The American Dental Association, and its state and local societies, have been fighting against the implementation of new mid-level dental providers—Dental Health Aide Therapist or Dental Therapist—since the introduction of the concept in Alaska over a dozen years ago. These new providers can do

surgical, non-reversible dental procedures. To date, only three states have passed legislation allowing these mid-level providers: Alaska, Minnesota and Maine. DHATs are operating in Alaska and DTs are practicing in Minnesota. Currently, no dental therapists are working in Maine, as legislation was only passed in 2014 and the program is slowly being implemented.

The Kellogg and Pew Foundations are supportive of this new type of provider and are working hard to pass legislation in a number of states. This year, the ADA has seen legislative or other activity in 18 states. The ADA estimates that both foundations have spent tens of millions of dollars over the past five years to pass state legislation.

No DT legislation has been signed into law so far this year. This is a significant achievement given the amount of money that both foundations have put into the passage of such legislation."

This is only one of the examples of how ADA, NYSDA, and organized dentistry work, and why it is so important to remain united and to grow in numbers. This is the most effective way to protect our professional interests and the interests of the patients we serve. I request as many members as possible to get involved. Convince your friends and colleagues to join as well so that we can truly represent the concerns of our diverse group!

## Technology and Dentistry

Through the efforts of NYSDA, EDPAC and the component societies, the e-prescribing mandate was pushed back a year. However, the technological future of the dental office is now here. The offices that are purely paper and pen are disappearing. This will bring many advantages—and also some concerns.

It has come to our attention that incidents of computer “piracy” have occurred to some dental practice management systems in New York. It more than likely starts when someone in the office clicked on a link or opened an attachment in an email. When that happens the offices entire computer system is taken over and a message is displayed on the screen that to access the system again a ransom paid in bitcoin (an untraceable digital currency) must be made. If the ransom is not paid, the entire system will be unusable. The “pirates” who are doing this are overseas, so there is very little that law enforcement can do in these circumstances.

The smartest thing to do is never to open an attachment to an email or click on a link in an email unless it is from someone you know and you were expecting that email. If someone does accidentally allow this to happen, it is highly recommended that you ensure your back-up protocols are in place and functioning properly. That way you can at least recreate your data without having to pay the “pirates.” A New York dentist who was paying monthly for a backup system but did not hook it up properly was one of the victims of these “pirates.” He had no choice but to rebuild his entire database, as he was not willing to pay the ransom, especially with no guarantee of getting his system back afterwards. If you have questions about your systems backup status, please ask your software provider for assistance.

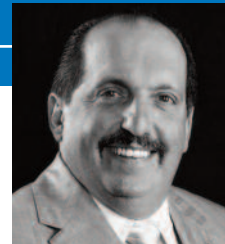

## Changing Trustees

It has been both a pleasure and an honor to have served as the First Trustee from Queens under our new governance structure. I was afforded the opportunity to provide leadership and guidance as we transitioned from a Board of Governors to a full Board of Trustees and a House of Delegates; being appointed chair of the important Compensation Committee of the Board.

During my tenure as a member of the Board of Trustees, we were able to accomplish many goals. I will name just a few:

- We led the fight against Invisalign, as they sought to establish quotas in order to use their system. New York State stopped this national campaign by passing legislation to make this illegal in our state, causing Invisalign to reverse their policy.
- The Board worked to elect Bill Calnon president-elect of the ADA.
- We worked to maintain the provision that continued adult dental services under the New York State Medicaid program.

• We advocated for, and were influential in the passing of the 80/20 law that requires at least 80 percent of all state dollars that fund healthcare to go to patient care.

• The Board worked with the OMIG to resolve audit problems, especially the controversial extrapolations that cost members significant fines in the past.

• We stopped Cigna from using a star rating system for dentists based on how much they charged patients. Three stars went to the dentist who charged the least fees to the managed care program.

• We established and operated the first MoM event in New York State, which was a tremendous success.

• We sought, and obtained a \$250,000 grant from the Health Department to create oral health demonstration projects in rural areas.

• The Board worked to develop a curriculum integrated format exam and pilot test it in New York State. This exam will eliminate all ethical problems associated with the current Board exams.

• Many surrounding states have been targets for mid-level provider models, but the leadership of NYSDA has kept this issue from our borders.

I had the privilege of serving as the chairman of the Committee on Annual Sessions during our own Dr. Chad Gehani's term; serving as his meeting chairman.

In addition to these duties during the past 5-plus years, as an EDPAC leader, first as vice chairman, then as treasurer, we saw our PAC grow in influence and size. There has never been a dental health bill passed that NYSDA objected to. The dental hygiene community was looking to pass an expanded function bill, but we stopped this and passed our own collaborative practice bill requiring the hygienist to always work with a dentist in Article 28 facilities.

As chairman of NYSDA Support Services, I led our Board to grow our for-profit subsidiary past the one million dollar mark and to continue to produce a steady and growing stream of non-dues revenue for NYSDA.

None of the accomplishments of NYSDA, and its different "arm's length" entities, would have been possible without the input and tremendously diligent work of our executive director as well as the NYSDA staff.

I look forward to continuing to work for our organization as chairman of NYSDA Support Services, treasurer of EDPAC, and as a member of the NYSDA Council on Governmental Affairs. I have complete confidence that Dr. Prabha Krishnan will serve excellently as my successor with all of her seemingly limitless energy and ability.

Again, thank you for this opportunity.

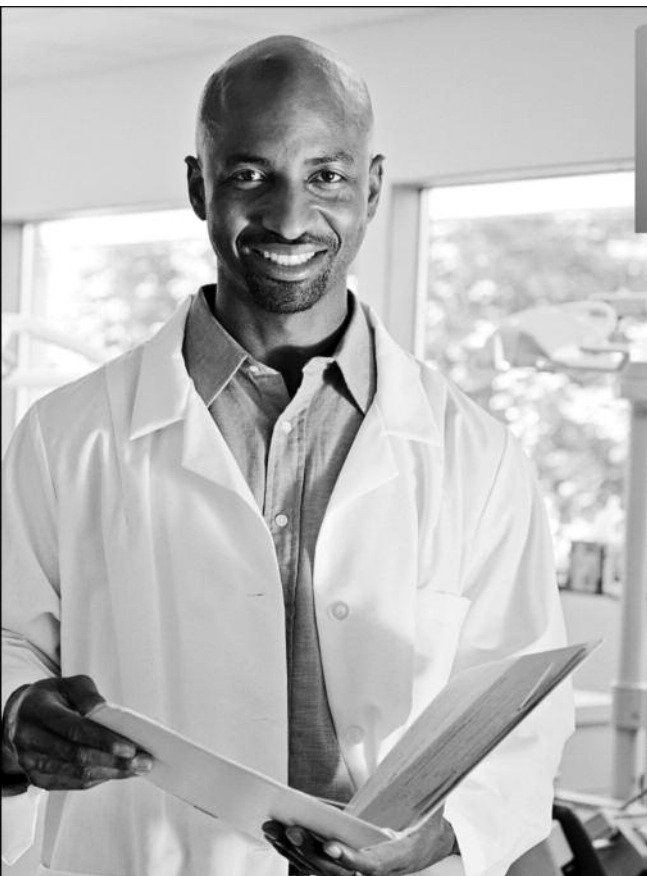

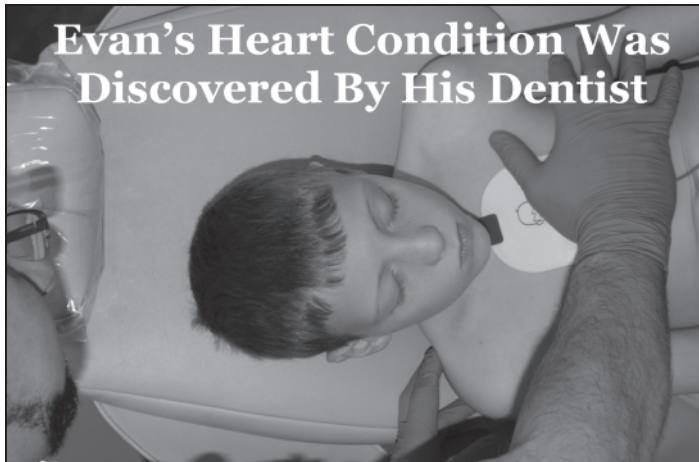

## Medicare and Dentistry: Implications and Clarifications

items or services for Medicare beneficiaries. This includes Medicare providers that do not and will not send claims to a Medicare Administration Contractor for services they furnish. The CMS permits such providers to enroll for the sole purpose of ordering or referring services for Medicare beneficiaries. There is no application fee associated with any status for individual providers. This is a part of the restructuring of CMS that will provide quality care and save the federal government \$1.6 billion over the next ten years. This will also give CMS enhanced tools to prevent fraud and abuse in the Medicare Part D program and will continue to protect beneficiaries and taxpayers.

As of June 1, 2016, all providers that write prescription for Medicare eligible beneficiaries must be enrolled in the Medicare system through the Medicare Provider Enrollment Chain and Ownership System (PECOS) in order for Medicare beneficiaries to obtain coverage through Medicare Part D. Basically, it means that all providers including dentists that treat Medicare beneficiaries, and write prescriptions for patients must have a formal status established in the CMS system or the prescription will not be covered when the patient goes to the pharmacy. In addition, if a dentist were to refer a patient for a Medicare Part B covered service, the treating doctor would only be eligible for Medicare payments if the referring doctor had a formal status with Medicare.

It's a change that the ADA does not agree with and one that ADA voiced their concern about in a letter to CMS. The ADA president and executive director sent a letter to CMS asking that dentists be excluded from this requirement, as it places an unnecessary burden on dentists and their Medicare eligible patients and will not address the underlying rationale for a portion of the law which is to stop fraud and abuse in the Medicare Part D program. Despite the ADA's expressed concerns, CMS moved forward with the enrollment or opt-out requirement.

Complying with this law will save providers much time and aggravation. Dentists have the following options, but the best option for most dentists seems to be the one that makes them an ordering or referring provider.

- Enroll as a Medicare provider (link form CMS-855I) <http://www.cms.gov/Medicare/CMS-Forms/CMS-Forms/Downloads/cms855i.pdf>
- Enroll as an ordering or referring provider (CMS form 855O link) <http://www.cms.gov/Medicare/CMS-Forms/CMS-Forms/downloads/cms855o.pdf>
- Opt-out of the Medicare program. One can opt-out by submitting an affidavit. This is an ADA member benefit and member login is required. The link to the ADA website for a sample opt-out affidavit is: [https://www.ada.org/~media/ADA/Member%20Center/Members/Legal\\_RevisedMedicareOptOutAffidavit\\_2015May7.ashx](https://www.ada.org/~media/ADA/Member%20Center/Members/Legal_RevisedMedicareOptOutAffidavit_2015May7.ashx)

All forms and affidavits are to be submitted to: National Government Services Inc., P.O. Box 7149, Indianapolis, IN 46207-7149. The ADA website also provides sample private contract forms that providers, if opted out, should use when providing Medicare covered services to Medicare patients.

### Durable Medical Equipment Provider

Medicare does provide coverage for oral obstructive sleep apnea appliances in certain instances. The benefits are provided under DME contracts (Medicare Part B) and require that a provider be enrolled as a participating provider in the Medicare program and is a registered DME provider, in addition to being a participating provider.

There is not one right answer for every practice; the choice will depend on the number of Medicare patients in your practice, the type of procedures you perform, and the overall makeup of your practice.

### Traveling Abroad

Medicare and Medicaid do not cover your healthcare costs while you are traveling outside the US. Read the fine print, in the important information section of your passport.

Does a dentist have any reporting responsibilities after enrolling in Medicare as a provider? One consequence of enrolling in Medicare is a duty to report "Reportable Events" to CMS. All enrollees must report change of ownership or control, change in practice location, or any final adverse action within 30 days of reportable events. All other changes must be submitted within 90 days of reported events.

DME providers are to report change of ownership or control within 30 days of reportable event. All other changes must be submitted within 90 days of the reportable event.

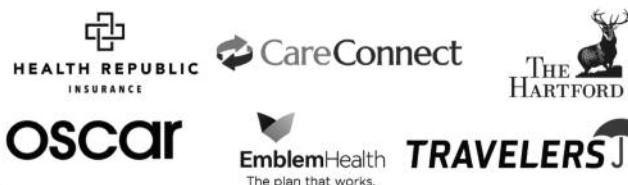

# New Use For Irrevocable Trusts For Elderly Clients With Declining Mental Faculties

There is an alarming trend among elderly clients who choose to remain home and have home health care workers provide 24/7 coverage.

The vast majority of home health care workers are scrupulously honest, attentive, loyal and caring workers. Occasionally, an unscrupulous HHCW uses his or her position to take financial advantage of a client. There have always been stories about clients reporting jewelry missing and suspicions about whether or not the HHCW was involved. The obvious answer to this problem is to put all valuable jewelry in a safe deposit box if there is going to be a HHCW in the residence 24/7.

A more serious problem has developed involving finances.

A local bank recently froze a client's account because the bank's computer detected an unusual withdrawal pattern. Upon investigation, it was determined that the HHCW had induced the client to withdraw funds to assist the HHCW who was experiencing financial problems.

A second incident recently occurred where a HHCW became intimate with a 95 year old widower (Viagra does work).

At some point the widower notified the brokerage firm which held a \$4 million brokerage account, to change the title of the account from John Jones to John Jones TOD Mary Smith. The TOD stands for "Transfer on Death" and the consequence is that upon the death of John Jones, Mary Smith automatically becomes the owner of the account.

If someone had been monitoring the monthly brokerage statements, they would have noticed that the name on the account had been changed.

In this particular instance, the client died and Mary Smith was able to obtain a death certificate for a modest \$10 fee from the city clerk, presented the death certificate to the brokerage firm, had the account transferred to her, and she then proceed to withdraw all funds and return to her homeland country. Actually, the family didn't find out about this until after the funeral, when they proceeded to marshal the assets and dis-

covered that the primary brokerage account had been reduced to zero.

Both of these incidents could have been avoided if the client executed an Irrevocable Trust and transferred his or her assets to that trust. The Irrevocable Trust would be structured as a grantor trust so that all income would be taxed to the grantor. There would be no gift tax consequence because the trust would include a limited power of appointment, which avoids any gift tax exposure. In addition, the assets of the trust would be included in the grantor's estate and receive a step up in basis at death. The trustees of this trust would be the children or some other trusted advisor or a corporate fiduciary.

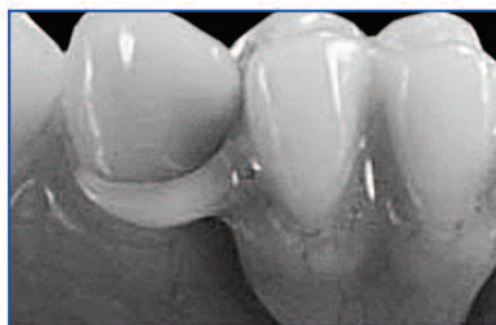
