



For example, in a budget-cutting move, California removed dental coverage for three million poor and disabled adults.

The present economic climate and budget deficits in many other states has caused states to focus on cuts in public health programs, with dental benefits for Medicaid recipients often a target of these cuts. Seven states have exercised their option under Federal law to provide no dental coverage whatsoever as dental coverage is considered "optional." Be glad you are not a low-income resident of Alabama, Delaware, Virginia, Texas, Colorado, Missouri or Utah in need of dental care, as these states offer no coverage. We are fortunate that NYSDA has been able to demonstrate the benefit of adult Medicaid coverage as well as to educate legislators on the relationship of one's dental health to one's overall systemic health, thus resulting in New York maintaining its program of adult dental coverage for Medicaid recipients. Your continued membership provides the necessary resources that allow organized dentistry to protect the patient and dentist from policies that may have adverse effects on dental health. Please encourage any practitioners who have not yet decided to become members of organized dentistry to contact me so that we might maintain the strong voice heard by our legis-


CRESO Corner: X-Ray Imaging


There are five contributing factors in making an x-ray image. They are kVp, mA, time, processing and SID (source to image distance). Quickly, mA and time or mAs have a direct relationship to output or the optical density on an image. The kVp has an indirect relationship where the rule of thumb is for a 15 percent increase in kVp you will almost double the output. Film processors can affect the image depending upon temperature, length of time and strength of chemistry in the developer solution. With digital images, the type of sensor and software setup is the key. SID affects radiation due to the inverse square law. I would like to address the effects of time and kVp in this article.

I have run into some dental facilities that have upgraded the type of film (from D speed to E/F speed) used or going to digital sensors, but have not made the proper adjustments of lowering their timers. Part of the problem is that dental assistants are placing the cone too far from the patient (SID).

more than 30 pulses or .5 sec. For those facilities using E/F speed film, the setting should be no more than 15 pulses or .25 sec. Those who are using direct digital systems (wire from sensor to computer), no more than 10 pulses or .16 sec. If you have the indirect PSP or CR system where you have to place the sensor in a laser reader, then your setting usually will be a little higher than the direct digital settings and sometimes a little higher than the F setting. If your timer settings are below these, you are probably in good shape. If not, you should try to lower your timers gradually (one setting at a time for one image only) until vou can get a satisfactory diagnostic image at a lower setting. I find that when timer settings are not in the above ranges your unit's kVp is usually not at the manufacturer's rated level. I have seen 70 kVp units firing at anywhere from 50-90 kVp. What does this mean? If your unit is at 50 kVp then you will need to increase your timer setting to get a good diagnostic image, sometimes for D speed film to almost 50 pulses or even 1 sec. Conversely, if your unit is firing at 90 kVp



Temporary Repeal of Federal Estate Tax 2010

Congress has allowed the unimaginable to happen. The federal estate tax has been temporarily repealed for calendar year 2010. Prior to 2010, the federal estate tax was imposed on estates in excess of \$3,500,000 (or \$7,000,000 for husband and wife) with a tax rate of 45 percent.

If Congress does not pass any legislation in 2010, the federal estate tax is repealed for one year and will be reinstated effective January 1, 2011 with an estate tax on assets in excess of \$1,000,000 (or \$2,000,000 for husband and wife) with a tax rate of 55 percent.

In addition, in calendar year 2010, any sales of inherited assets (stocks, bonds, real estate, etc.) in excess of \$1,300,000 (or \$4,300,000 if there is a surviving spouse) will incur a capital gains tax based on original cost basis. This is different from the law in effect prior to 2010 which provided that all assets inherited from the decedent received a step up in basis to fair market value at the date of death so that only sales at a price in excess of the fair market value at the date of death would incur capital gains tax on the excess.

Congress is currently considering at least four different options:

Permanently repeal the federal estate tax but continue to impose an income tax on sales of assets in excess of basis (cost) plus \$1,300,000 if there is only one decedent or \$4,300,000 if there is a decedent and a surviving spouse.

Reactivate the federal estate tax retroactive to January 1, 2010 and continue the step up in basis rules for income tax purposes and a \$3,500,000 credit for the first decedent (\$7,000,000 for husband and wife) for federal estate tax purposes and a federal estate tax rate of 45% (the law in effect on December 31, 2009).

Reactivate the federal estate tax retroactive to January 1, 2010 with a \$5,000,000 credit for the first decedent (\$10,000,000 for husband and wife) and a 35% rate. This proposal is currently being proposed by several congressmen.

Extend the federal estate tax law as it existed on December 31, 2009 for a two year period (retroactive to January 1, 2010) and revisit the subject after the 2010 elections.

It is impossible and unrealistic for anyone to predict which option Congress will enact.




Most authorities agree that any retroactive reinstatement of the estate tax to January 1, 2010 should survive a constitutional challenge.

Many individuals have Wills which create a "credit shelter trust" (\$3,500,000) for the benefit of the surviving spouse and ultimately children or children and grandchildren. These types of Wills will automatically adjust to whatever credit level (\$1,000,000, \$3,500,000, \$5,000,000 or any other amount) Congress designates.

If an individual has a designated beneficiary for the \$3,500,000 credit shelter trust (for example, children of a first marriage) that is different from the beneficiary of the marital deduction portion (assets in excess of \$3,500,000 payable to a surviving second spouse), there is a need to review and possibly revise such Wills now in case there is a premature death in 2010 before Congress acts. Such a disposition of assets could be adversely affected by the 2010 repeal.

QCDS Bulletin, chairman of the Greater Long Island Dental Meeting and was a clinical professor of orthodontics at both the Columbia University School of Dentistry and the New York University College of Dentistry. He was honored with fellowships in the International College and the American College of Dentists and received QCDS's highest recognition, the Distinguished Service Award, in 1981.

Dr. Lasoff often commented that he felt education was the cornerstone on which a successful dental practice was built and his actions spoke louder than his words as evidenced by his 30 years at Columbia University and his more than 20 years at New York University. He felt fewer dentists today choose to work in academia resulting in a serious shortage of faculty. Dr. Lasoff felt it is vital to the profession that dentists get involved in teaching and give back to the profession. Most importantly, he noted, "as a teacher, you get the satisfaction of helping a student learn and improve their skills."

Dr. Lasoff was active with the ADA, NYSDA and many QCDS committees over the years, where he had a particular fondness for helping practitioners with drug or alcohol issues and was a valued member of NYSDA's Chemical Dependency Committee as well as a strong supporter of the Daytop Program.

As one would imagine, Dr. Lasoff observed many significant advances in the field of dentistry during his 65 years of practice—endodontics was created as a specialty, improved dental materials allow practitioners to create smiles and improve the quality of patient's lives, state of the art dental equipment has enhanced success rates for dental procedures and today's dentists utilize technology that was only dreamed of when he graduated dental school. To Dr. Lasoff, these changes improve the quality of life for patients and can only enhance a sense of satisfaction in the dental profession.


TAX TIPS FOR DENTISTS

he IRS has suspended the mandatory withdrawal rules from pension plans and IRAs for 2009. You will not have to add the skipped payment to your 2010 withdrawal. Your 2010 withdrawal will be based on your age and December 31, 2009 balance. Inherited IRAs and pensions get the same break. If you turn 70.5 years of age in 2009, you needn't take any pension withdrawal.

After a number of NYSDA officials and ethnic association leaders joined in the congratulatory speeches, the evening concluded with entertainment that was enjoyed by all.

The program continued on Saturday with a dialogue between participants and local elected representatives about concerns of the dental community, shared with the elected officials or their representatives. In addition to Assemblyman Espaillat, Assemblyman Carl Heastie and Lillian Perez, Senator Eric Schneiderman's chief of staff, noted the importance of voicing concerns to your elected officials and that legislators actually depend on such input to educate them regarding the many technical issues that come before them. They felt communication with legislators both by professional associations as well as one-on-one contacts establishes relationships that are mutually beneficial. Current issues, including forgiveness of loans for dental graduates, out-of-state students in New York residency programs, proposed malpractice reform, Medicaid funding and reimbursement, among other issues, were discussed in a give and take session with the officials.

EDPAC Chair Dr. Lawrence Volland reiterated the importance of maintaining open lines of communications

with elected officials and encouraged all present to support NYSDA's efforts to educate elected leaders on issues effecting dental practitioners and their patients. Without such educational efforts, adult dental services under the Medicaid program may have been eliminated as a budget saving device, without regard for the serious negative impact on the dental health of those unable to afford dental care.

QCDS supported this forum, which also received support from the Second District and Bronx County Dental Societies, NYSDA, the New York State Dental Foundation, the ADA, and the Indian, Puerto Rican, Hispanic and Dominican Dental Associations and Henry Schein Company.

Dr. Breault congratulated the organizers, reiterating the importance of this interaction, and felt the forum provided for an exchange of ideas and concerns about the difficulties facing all dentists. Dr. Doherty encouraged all members of the ethnic associations to become tripartite members, thus increasing the strength of organized dentistry. Dr. Feldman's observation that the meeting was productive and meaningful, with much information exchanged, leaving all more informed, was echoed by all who attended.
