

Dr. Roth has served in many leadership positions before concluding her term as ADA president in October of 2007, including a four-year term as ADA trustee for the Ninth District.

QCDS, in partnership with the New York State Dental Founmember of the ADA Council on Membership and Communications and held various Board assignments with the ADA and Wisconsin Dental Association. She has testified before Congress on behalf of dentistry and was a speaker at an international dental congress in New Delhi, India. Her many honors include being a Fellow of the International College of Dentists and the American College of Dentists, as well as a member of the Pierre Fauchard Academy.

Dr. Steinberg's presentation will address the psychological, medical and dental issues associated with eating disorders. Attendees will be able to identify oral conditions associated with eating disorders and become familiar with dental management of the eating disordered patient.

Dr. Steinberg received her DDS from the University of Maryland School of Dentistry and completed a residency at the Medical College of Pennsylvania. She is a clinical professor of surgery at Drexel University College of Medicine, as well as an adjunct associate professor of oral medicine at the University of Pennsylvania School of Dental Medicine. She specializes in the treatment of medically compromised patients. As a nationally and internationally invited lecturer in the area of dental treatment of the medically compromised patient and women's health, she has authored numerous articles and contributed to major textbooks on these subjects.

QCDS events, including oral health screenings and health fairs. She is a Fellow of the International College of Dentists and Fellow of the Pierre Fauchard Academy,



Backflow Prevention Device Update

I hope you all had an enjoyable summer and have had a sending the owners a fine without notice. chance to relax a little. I am also hoping that the economic problems we are facing now have not given you too much aggravation and anxiety. A large part of summer is water, and clean water is always best. We are also always looking for ways to save money and avoid violation and fines. This leads me to the reason for writing this note. DEP has recently changed their policy and will further change their policy on enforcing the backflow prevention program with violations and fines.

More specifically, if you receive a letter stating that you have a certain time to comply with the filing of plans and installation of the Backflow Device and you don't comply, you will receive a violation notice to appear at ECB court, with a maximum fine of \$1,000. This will shortly change to be a straight fine without an option to appear at a hearing. They will further implement fines for not testing devices and overhauling every five years. I found this out the hard way when one of my clients recently received a notice from DEP for not submitting plans in a timely manner. They used to let architects submit plans when they had completed them and if there were any concerns, they would notify us in writing to tell us to hurry up. Now they just send the owners a violation notice, and in the future will be

If any of you have ever sat for half a day at the ECB court waiting to be heard by a judge, you know that it is not a picnic, plus paying hundreds of dollars for fines is also not fun. Would you like to know how you can avoid this problem and have no headaches when it comes to backflow compliance? Take this letter very seriously and hire professionals who have a history and experience in designing and installing the devices guickly and inexpensively. If you are already in the process of compliance, make sure you watch and direct your professionals very closely because in the end, the violation and fine will be your responsibility, not theirs. From The Executive Director



Meeting Requirements

I receive many phone inquiries regarding courses that are fice while the exempt dentist is seeing patients. "mandated" and the member is unsure of how often or when such courses must be taken. I also have spoken to many members who have trouble paying their dues in a single payment. Hopefully the following will clarify many of your questions.

NYSDA offers a five-installment payment plan to stagger your dues payment, which may be of interest. You need to enroll in this program for next year by September 30. Further information is available on the NYSDA web site for those who wish to explore this option.

Beginning July 1, 2008, the number of hours needed to reregister increased from 45 hours per three-year registration to 60 hours per three years. The requirement will be prorated for each month beginning July 1, 2008 until the end of the licensee's registration period. All subsequent triennial registration periods beginning on or after July 1, 2008 will require the completion of 60 hours of continuing education. The State Education Department offers a CE calculator on their website www.op.nysed.gov/dentcechap183.htm which will provide you with the specific number of prorated CE hours you will need, depending on your registration renewal date. A maximum of 18 hours can be self instructional.

Infection Control: All dentists must complete course work or training appropriate to their practice regarding infection control and barrier precautions, including engineering and work controls to prevent the transmission of human immunodeficiency virus (HIV) and the hepatitis b virus (HBV) in the course of professional practice, every four years according to Section course information for posting on your record if courses are 6505-b of the Education Law. You must attest to having completed this requirement to the State Education Department on your first licensure/registration application and at every subsequent registration.

Child Abuse: The course must be completed once during your career and is usually taken as part of your dental school curriculum if you attended a dental school in New York.

Continuing Education in Ethics and Jurisprudence: During the next registration period beginning on or after January 1, 2008, each dentist who is required to complete continuing education must, on a one-time basis, complete a three-hour course in New York State jurisprudence and ethics approved by the State Education Department. By now, most of you have completed this program which is a once in a life time requirement and should be completed by January 2011.

CPR: As of January 1, 2009, all dentists must receive and maintain certification in cardiopulmonary resuscitation (CPR). If a dentist is physically unable to perform CPR, he or she may request an exemption by submitting an application for exemption. The request must be accompanied by a statement from the professional treating the disability and a signed assurance naming another individual or individuals hope a large number of our members will be on hand to welwho will maintain CPR certification and be present in the of-

The State Education Department web site at www.op.nysed.gov can be searched for most information regarding any questions you might have related to dental regulation, including the online license renewal program.

Although Risk Management is not a mandated course, many malpractice carriers offer significant premium reductions for those who complete an approved Risk Management program. Check with your carrier to verify that they accept the course for premium reduction. The discount is usually applicable for three years and offers a relatively painless method to save money on your malpractice premiums. This program is similar to the Defensive Driving program, which offers similar savings on your automobile insurance premiums. In these economic times, one would be foolish not to take advantage of these discounts which are obtained by simply attending a course offering for a few hours. Our next Risk Management course is September 11 and requires pre-registration.

As a member benefit, an electronic transcript of your CE courses is maintained on the NYSDA website, which can only be accessed through their secure portal. Members have access to an up to date registry of all CE activity during the last six years and NYSDA will issue an "official transcript" acceptable to the State Education Department in the event your CE is audited. While CE courses taken under QCDS auspices are automatically transmitted by QCDS staff to the registry on your behalf, it is your responsibility to supply NYSDA with taken elsewhere. It is a good idea to check the site www.nysdental.org periodically to verify that your CE postings are accurate. Note that annual CE transcripts are no longer being mailed to you.

While on the topic of CE offerings, congratulations are in order to our members who completed CE milestones at the end of 2008. A complete listing of CE awards beginning at 100 hours is found elsewhere in this Bulletin. Special recognition is due to Dr. Risa Samuels, who has completed 1,500 hours. Close on her heels are Drs. Jay Ledner, Ira Schwartz and Howard Winter, all of whom have completed 1,000 hours. We encourage all of our members to participate in our CE programs, which are offered at little or no cost. We welcome suggestions for program topics, too.

We are fortunate to have had a number of notable speakers at our 2009 membership meetings, including Drs. Charles Bertolami and Ira Lamster, the deans of the dental schools at NYU and Columbia University, respectively. Continuing with this good fortune, Dr. Ray Williams, the dean of dental medicine at Stony Brook and an expert on periodontal disease, will be speaking at our October 13th membership meeting. We come Dr. Williams, who has come to Stony Brook after a long and distinguished career at the University of North Carolina at Chapel Hill School of Dentistry, where he has been on the faculty since 1994. Our thanks to these three leaders in the field of dental education who have made time in their busy schedules to appear at our meetings and share their thoughts on a variety of topics with us. We are fortunate indeed!

I am also pleased to report that Martin Schnee of Big Apple Radiation Safety has affiliated with QCDS in conducting required x-ray inspections to our members. As many of you know, New York City privatized the inspection function several years ago to Certified Radiation Equipment Safety Officers (CRESO). The inspection is required every five years and must be performed by a CRESO while the registration of the x-ray unit registration is on a two year cycle. Mr. Schnee is the former chief of the Radiation Equipment Division for the Department of Health, with over 34 years of experience with the New York City Bureau of Radiological Health. I have already received positive feedback from members who have used his services and believe he is a valuable resource for our members. He can be reached at 718-373-6348 and his ad can be found elsewhere in this issue.

I understand NYSDA has concluded the search for the executive director position and Dr. Mark Feldman, former ADA President, is the selection. Dr. Feldman's leadership experience will be a great asset to NYSDA and I extend our congratulations to Dr. Feldman, who I expect will be no stranger to QCDS events.

I ask your cooperation in providing an e-mail address if you are called by a QCDS staff member. In order to communicate with you more effectively and more economically, we are updating our e-mail list to assure all members receive timely notifications of upcoming events or matters of importance. By cooperating, you help us help you. In addition, the development of our website continues and on-line registration for CE courses is now available. I encourage you to try this feature which generates a confirmation to you via e-mail. If you encounter problems, please contact the QCDS staff for assistance. Comments or suggestions are welcome regarding any aspect of the web site.

On a somber note, I received information that Dr. Saul Greenberg, a QCDS past president, recently passed away and we extend condolences to his family. Dr. Vincent Genna, longtime QCDS member, also passed away, on June 24.

NOTE: The Federal Trade Commission has again delayed the implementation of the "Red Flags Rule" which is aimed at preventing identity theft, until November 1 in an effort to clarify its applicability to businesses such as dental offices. Further information is available at the FTC website, www.ftc.gov/redflagsrule as well as on the ADA and NYSDA websites.

I also ask that you support those sponsors who support QCDS. Calling CRESO

By Martin Schnee, Big Apple Radiation Safety

By this time, every dentist should be aware that the New York City Department of Health is no longer performing dental x-ray inspections. This duty has been passed on to a group called CRESO, Certified Radiation Equipment Safety Officers, New York State Health Department certified physicists. The City still reserves the right to do a follow up or reinspection at its discretion.

The process is that the Office of Radiological Health notifies you by mail when your five-year cycle inspection is due and also supplies you with a list of CRESO inspectors. You will choose and pay CRESO for the inspection, not the City. The City allows you several months beyond your due date to have the inspection performed. Be cautious when hiring a CRESO inspector, in that prices may vary and, more importantly, finding someone with the experience to improve the quality of your imfor the public, not hidden in your desk drawer. Judges will not ages while being familiar with the regulations. Most staffs I inspect have a bevy of questions about radiation and are eager to that you sent it in but don't know what happened. Renewal aplisten and learn.

An important item to note, before you set up a date for inspection, is to verify that your registration is valid. What is meant by valid? Is the facility registered to the correct owner? Is the address correct? Has the expiration date been reached? Registrations are not transferable by name or address. Registrations are for a two-year period. Every facility containing operable (unit operates even if not being used) x-ray equipment shall be registered and inspected.

If you are opening a new office or taking over someone's

practice, regulations require that you register your new facility 30 days prior to operation. Former Health Commissioner Dr. Thomas Frieden, introduced a requirement that, in a new dental office, x-ray equipment may not be registered or used on patients until first inspected by a CRESO inspector and the New York City Department of Health has reviewed the inspection report and receives a \$100 fee.

Note that the Federal papers filed by the installer of x-ray equipment do not constitute a request for a New York City registration or substitute for a CRESO inspection.

One registration certificate is sufficient to cover all the x-ray equipment in a dental office. If you add additional equipment or upgrade, you do not need to make any additional registration modifications. The City will also allow you to wait for your cycle inspection to have any new equipment inspected.

Remember that registrations are to be conspicuously posted accept an excuse that you did not receive the renewal by mail or plications should be received six to eight weeks prior to expiration. Call 212-487-4060, 80 with your CAMIS ID number for renewal problems or questions. Call 212-676-1552 for new registration questions.

To verify your inspection date, call either number and give your CAMIS number to the clerk. Then ask them to look up your last date of inspection. Just add five years to the date.

Early in the 20 century, dentists and physicians believed that oral infection-oral sepsis was responsible for causing or contributing to most of the diseases that occurred in humans. Victory With Office Based Surgery Regulations

NYSDA and the new NYSSOMS are sharing a victory in their cooperative effort of having DDS/MDs limit their practice to dentistry. They are now exempt from a law to take effect this week that would have required them to expend resources on meeting office-based surgery accreditation requirements.

This victory is due to the cooperative work of NYSDA and the New York State Society of Oral and Maxillofacial Surgeons. The groups were successful in persuading the New York State Department of Health to restate its interpretation of the 2007 New York State Office-Based Surgery Law to definitely conclude that dual-licensed dentists are exempt from this law when they limit their practice to dentistry.

he IRS has suspended the mandatory withdrawal rules from pension plans and IRAs for 2009. You will not have to add the skipped payment to your 2010 withdrawal. What Works When It Comes to Employing An Associate in Your Dental Practice

Hiring an associate to work in your practice can be a win-win for everyone. For the owner, an associate can fulfill a number of important roles. And for the associate, it can provide the kind of experience that helps to build confidence, a long-term career path, or just a source of additional income.

There are a number of reasons why practice owners choose to have an associate:

To help grow a busy practice;

To offer patients additional procedures or services that the owner does not have the time or wish to perform;

To allow the owner to reduce work hours without sacrificing income:

To enable the owner to open a second location by having the associate provide full-time coverage; and

To prepare for transition/retirement.

Dentists practicing in Queens County are generally in a good hiring position, as the area attracts younger dentists as a place to live and practice. With several dental schools in the New York area and a shortage of practice ownership opportunities, many newly graduated dentists are seeking part and full-time associates' positions.

From the Owner's Perspective

An owner considering an associate should first understand his motivation for hiring an associate and seek to hire the type of professional whose ambition and philosophies of patient care are consistent with his own.

When meeting with potential associates, be clear about the position and its future potential. The two of you should discuss the following in detail:

- Expectations on dental production and quality of work;
- Hours, remuneration and benefits, and
- Office management responsibilities.

If you are seeking an associate who can eventually become a partner, we suggest that these arrangements be discussed prior to the start of the associateship. A written agreement is the best way to ensure that both of you are on the same page with respect to key aspects of this relationship.

The agreement should spell out:

- The length of the associateship phase;
- Financial arrangements to buy in;
- Respective duties of each dentist;
- A reasonable non-compete agreement, and
- Timing of key transition events.

From the New Practitioner's Perspective

Many dentists just starting out are looking for a few years of employment before establishing their own practice or finding a position that better suits their long-term needs.

It's always a good idea to gain experience in a few different types of practices, whether it's fee for service versus insurance driven or cosmetic versus drill and fill. It's also beneficial to work with patients representing a range of income levels, from blue collar to middle and upper middle class. This is the best way for new practitioners to start figuring out the type of practice that will ultimately be the best fit for their personality and treatment style.

Young dentists who are looking for a long-term relationship with a buy-in opportunity should state that expectation upfront. If there have been previous associates in the practice, it's a good idea to ask the owner why the other associates left. If the owner is offering a buy-in opportunity, we recommend getting the key aspects spelled out in writing so there are no surprises for either doctor.

Engaging a transition specialist with expertise in structuring associate buy-ins can also go a long way towards facilitating this type of transaction. That professional should do a practice valuation, advise on all key points of the agreement, and have the skills to negotiate a successful transition for both parties.

ARTICLE II · BOARD OF TRUSTEES

SECTION 1. COMPOSITION: The Board of Trustees shall consist of the following members:

A. The six (6) elective officers, i.e., President, President-elect,

D. Members of the Board of Governors Trustees of the New York State Dental Association, from this Society

ARTICLE III · ADMINISTRATIVE COMMITTEE

The Administrative Committee shall be composed of the President, President-elect, Vice President, Secretary, Treasurer and Historian of this Society, the Editors(s), the five (5) Immediate Past Presidents, the Governors Trustees of the New York State Dental Association, the Delegates to the American Dental Association House of Delegates and the Executive Director. They shall meet at the call of the President or on demand of any five (5) members of the committee. The Administrative Committee shall serve in an advisory capacity and shall, following deliberations at any meeting thereof, make recommendations on such matters, as it may deem necessary, to the Board of Trustees. The Administrative Committee is empowered to transact business of an emergency nature, whenever a regular or special meeting of the Board of Trustees is not scheduled. Such action shall be reported at the next meeting of the Board of Trustees and shall be subject to review by the Board

ARTICLE IV (OFFICERS AND REPRESENTATIVES

SECTION 1. ELECTIVE OFFICERS (Elected by the general membership): ...

SECTION 2. EDITOR(S): ...

SECTION 3. ELECTIVE REPRESENTATIVES: In accordance with the provisions of the Bylaws of the New York State Dental Association the following shall be elected by the membership, at the same time and place, and in the same manner as elective officers of this Society:

The Governors to the Board of Governors of the New York State Dental Association for a two year term, the term of each to expire alternately.

A. The Member of the Board of Trustees of the New York State Dental Association for a single four (4) year term, with the exception of the Trustee to take office in 2010, who shall serve a one-year term and may be re-elected to serve a full four-year term as provided in the NYSDA Bylaws.

B. Delegates and Alternate Delegates to the House of Delegates of the New York State Dental Association in numbers as specified by NYSDA. The six elective officers of the Queens County Dental Society shall serve ex officio as Alternate Delegates to the NYSDA House of Delegates. No member of this society may serve as both the NYSDA Delegate and Alternate Delegate concurrently. If a QCDS officer is serving as a NYSDA Delegate, then that Alternate Delegate position shall be filled from the General Membership. If fewer than six Alternate Delegates are required, the highest ranking officers of this society shall serve ex officio to fill the required number of Alternate Delegate positions. Any remaining number of Alternate Delegates required shall be elected from the General Membership of the Queens County Dental Society as provided in these Bylaws.

B. C. Nominees for Delegate(s) and Alternate Delegate(s) to the House of Delegates of the American Dental Association in numbers and tenure as specified by the New York State Dental Association. The nominees for first (1st) and second (2nd) Alternate Delegates shall be the President-elect and the Vice President respectively.

SECTION 4. NOMINEES TO THE NEW YORK STATE DENTAL ASSOCIATION:

In conformance with the Bylaws of the New York State Dental Association, a nominee to the New York State Dental Association to serve as a member of the Council on Nominations for a period of one (1) year the shall be elected by the Board of Trustees at the January meeting of the calendar year. The nominee for the office of Vice President of the New York State Dental Association shall be elected by the Oueens County Dental Society Board of Trustees at the regularly scheduled March meeting. In the event that there is more than one (1) candidate, the election shall be carried out in accordance with the rules outlined in Article VII, Section 2B of the Bylaws.

SECTION 5. TENURE OF OFFICE: The officers and members serving in elective or appointive positions, shall serve for a term of one (1) year, except as otherwise provided in the Bylaws, or as otherwise specified by the New York State Dental Association or the American Dental Association. Queens County Dental Society members of the Board of Governors of the New York State Dental Association; or delegates to the House of Delegates of the American Dental Association may not serve in the same capacity for more than six (6) consecutive years. One (1) member may serve concurrently as a member of the Board of Governors of the New York State Dental Association and as a delegate to the House of Delegates of the American Dental Association.

A. The Member of the Board of Trustees of the New York State Dental Association for a single four (4) year term, with the exception of the Trustee to take office in 2010, who shall serve a one-year term and may be re-elected to serve a full four-year term as provided in the NYSDA Bylaws.

B. Delegates to the House of Delegates of the New York State Dental Association shall serve for a term of office of one (1) year, and may not serve in the same capacity for more than six (6) consecutive years. C. No member may serve as both a NYSDA Trustee and NYSDA Delegate or Alternate Delegate concurrently. No member may serve as both a NYSDA Delegate and Alternate Delegate concurrently.

D. Delegates to the House of Delegates of the American Dental Association shall serve for a term of office of one (1) year and may not serve in the same capacity for more than six (6) consecutive years.

SECTION 1. NOMINATIONS FOR ELECTIVE OFFICE: Nominations for elective office in this Society shall be presented at the October stated general membership meeting of this Society. SECTION 2. ELECTIONS:

A. ELECTIONS BY THE GENERAL MEMBERSHIP. In electing the Elective Officers of the Society, the Governors Trustee, Delegates and Alternate Delegates to the New York State Dental Association, and the nominees for Delegate(s) and Alternate Delegate(s) to the American Dental Association's House of Delegates, ballots shall have been prepared prior to the November stated membership meeting at which voting for office shall be held. ...

ARTICLE XIV (FINANCES

SECTION 1. GENERAL FUNDS: ...

SECTION 2. RELIEF FUND: A special fund to be termed the Queens County Dental Society Relief Fund shall be formed according to the terms of the Indenture of Trust for the Queens County Dental Society Relief Fund. Such funds shall be deposited in banks authorized to receive such funds, or invested in securities at the direction of the Board of Trustees. Obituary

SAUL N. GREENBERG, DDS

Saul N. Greenberg, the son of a dentist, was born in Brooklyn, New York, on June 20, 1923. After graduating from New York University College of Dentistry in 1947, he pursued post-graduate training in Orthodontics at Columbia University. Subsequent to serving as an officer in the U.S. Army, he became a prominent American Boarded Orthodontist in Flushing. He was a professor of his craft at both New York University and Columbia University Schools of Dentistry. He distinguished himself in this capacity by being a mentor for an array of students from all parts of the world. He was highly respected by his peers, who sought his expertise. In addition, he organized the Orthodontic Program at Flushing Hospital and was a charter member of the Queens County Dental Society. Aside from authoring the unique text, "So You Want to Be a Dentist," he published numerous articles in distinguished professional journals. In recognition of his valued contributions to the profession, he was elected president of QCDS in the early 1980s. Sadly, he succumbed to the ravages of Parkinson's disease on July 20. He will be remembered as a kind, concerned, compassionate and loyal human being.
