As a long term member of QCDS, in addition to his private endodontic practice in Jackson Heights, Dr. Gehani has accomplished a tremendous amount for the dental profession and has slowly climbed the ladder of organized dentistry. He served as president of QCDS in 2003, president of the New York State Dental Association from 2011 to 2012, the International College of Dentists – New York Section in 2012, and the Indian Dental Association, U.S.A. from 1985 to 1986. In his many positions, he has served as a

mentor to numerous young dentists and paved their way for entry into leadership positions in our profession.

In addition, he has served as chair of the Department of Endodontics at Flushing Hospital Medical Center from 1987 to the present, and is an associate clinical professor at the College of Dentistry at New York University. He has also been a member of the New York State Dental Foundation since 2005.

Dr. Gehani has received numerous awards and recognitions over the years. Among these, Dr. Gehani has received the Emil Lentchner Distinguished Service Award from QCDS in 2013, New York State Dental Foundation's Award of Excellence in Community Service in 2006, and he was honored by the president of the Dominican Republic in 2003. Dr. Gehani has also earned fellowships with the Pierre Fauchard Academy, International College of Dentists, and American College of Dentists. Additionally, he is an international speaker and has presented numerous lectures in various countries in Southeast Asia.

# World's Fair of Dentistry: The Largest Dental Event Ever in Queens History

QCDS presented its second annual World's Fair of Dentistry—the largest dental event in Queens history—in September, providing an opportunity to meet and learn from close to 40 vendors while networking with colleagues.

Admissions was open to all dentists, not just those who are members of the American Dental Association, during the two day event, providing the opportunity to earn 14 continuing Education Credits.

"This was a great opportunity for us

to show the value of organized dentistry to those who are not members and to hopefully convince them of the importance of joining the Queens County Dental Society, New York State Dental Association, and the American Dental Association" said QCDS Executive Director Oleg Rabinovich.

### **Getting Ready for E-Prescribing**

As technology continues to advance and effect our practice, the New York State Dental Associations Task Force on Technology Applications, of which I am a member, has been hard at work taking a proactive position on the March 27, 2015 deadline for the mandatory New York State e-prescribing requirement.

I am happy to announce that the New York State Dental Association has created a great member benefit by signing an agreement with a major vendor to offer an e-prescribing solution. NYSDA is preparing and said, "This vendor has been thoroughly vetted by NYSDA's Task Force on Technology Applications, NYSDA Support Services and NYSDA leadership. NYSDA members will be entitled to a discounted rate for their software. The program has gone through the audit protocols required by DEA and BNE and our members will be given all the information they need to both register the software with the DOH, and comply with the two-stage identity requirements."

I anticipate multiple communications with our members, webinars on the "how to" basics of e-prescribing and a full issue of the New York State Dental Journal that will serve as an

operating manual for the software. Rather than have them wait on a telephone line (they will need to call in to satisfy some of the identity certification), we are attempting to have the vendor set up an online sign up and a call back. This is an enormous undertaking and we will do our best to satisfy all our members. The important message for the moment is "yes, NYSDA will have a state of the art, turn-key-ready software solution up and running for our members and it should be ready long before the March 27 deadline."

This is another example of how organized dentistry works for us. This information and effort will help to make our practices transition much easier and smoother.



# DENTAL MALPRACTICE INSURANCE UPDATE

**Topic: Negligent Treatment Plan Claims** 

#### **Recent Court Decisions**

The execution of a properly prepared written informed consent is widely understood to be necessary in the context of surgical procedures, but is often overlooked when treatment plans are being formulated. A review of case law and jury verdicts, however, makes clear that practitioners cannot rely on a simple written treatment plan to establish informed consent, and that it is necessary to secure proper informed consent before initiating any planned restoration.

In *Harvin v. Roth*, *et. al.*, a patient was provided two options for treatment of loose front teeth and receding gums. The patient signed the written treatment plan, agreeing to the treatment option recommended by the dentist. Following placement of gold/porcelain inlays, the patient required root canal and sued the dentist alleging lack of informed consent for "unnecessary restorative treatment" and a failure to advise of the risks and complications inherent in the treatment. Assessing the dentist's proof of informed consent, the court determined that there were issues of fact for the jury to decide.

Case law also demonstrates that pointing to a patient's signature on a consent form which lists the risks and benefits of the procedure is not, by itself, enough to defeat claims for lack of informed consent where the consent form does not address alternative treatment options, and the patient testifies that alternative treatments were never discussed. See, e.g., Giambrone v. Farha, et. al.; Rojo v. Young, et. al.

The American Academy of Cosmetic Dentistry predicts increases in the demand for veneer procedures and crown and bridge work. To protect against a corresponding increase in lack of informed consent claims, practitioners should take care to manage patient expectations for treatment outcomes and thoroughly communicate and document discussions regarding the necessity of treatment, the risks, benefits and cost of all treatment options, as well as the prognosis of proposed treatment and any refusal of preferred treatment.

#### **Practice Points**

**Focus**: Obtain proper written informed consent for all restorative treatment plans

- Provide patients with a WRITTEN TREATMENT PLAN identifying the necessity of proposed restorations, all known and foreseeable risks and benefits of the recommended treatment, and all treatment alternatives that are generally accepted among dentists in your community, inclusive of referrals to specialists.
- Obtain the PATIENT'S SIGNATURE to demonstrate their selected treatment option.
- IF RECOMMENDED
  TREATMENT IS REFUSED, determine whether it is appropriate to dismiss the patient. If it is acceptable to proceed, have the patient sign a statement that they are electing non-preferred treatment and document the reason (ex. inability to pay cost of preferred treatment).
- DOCUMENT YOUR
  CONVERSATION IN THE PATIENT'S
  CHART and reiterate the necessity of
  treatment, the risks and benefits of the
  options, and where preferred treatment
  options have been refused the short
  term goals and likely prognosis.
- Secure a properly executed INFORMED CONSENT FORM that is tailored to the elected procedure.

At the ADA Conference, I had the opportunity to interact with the leadership of state and local dental societies from across the country and I definitely got some good ideas that I would like to implement here in the future.



## ADA Finds Toothpaste Polyethylene Microbeads Should Not Be Removed

The American Dental Association's Council on Scientific Affairs, on an ongoing basis, monitors and evaluates the safety of all ADA Seal-Accepted products. If the council's evaluation determines sufficient scientific evidence exists that an ADA Seal-Accepted product poses a health risk, the council has the authority to withdraw the Seal from that product. At this time, clinically relevant dental health studies do not indicate that the Seal should be removed from toothpastes that contain polyethylene microbeads.

Polyethylene microbeads are an FDA-approved food additive. These microbeads are commonly used as scrub beads, such as in exfoliating products, but are also sometimes used in chewing gum and toothpaste, as part of the product design. Small quantities of the colored polyethylene specks are included in some of Crest's toothpastes, including Crest Pro Health, which has the ADA Seal of Acceptance.

The Council will continue to monitor and evaluate new scientific information on this issue as it becomes available. In the meantime, the ADA recommends that individuals continue to follow the U.S. Food and Drug Administration's recommendations on the use of dental health care products.

Products with the ADA Seal have been independently evaluated for safety and effectiveness by the ADA Council on Scientific Affairs. The ADA "Guidelines for Participation in the ADA's Seal of Acceptance Program" describe the general criteria for earning the ADA Seal. In addition, many product categories have specific product guidelines that give the types of safety and effectiveness studies required.


