

QCDS' Dr. Gehani Elected ADA President 'I'll Be Working Hard for You. Let's Work Together'

Queens County Dental Society Past President Dr. Chad P. Gehani, a practicing Endodontist in Jackson Heights, was elected president-elect of the American Dental Association in balloting at the ADA House of Delegates meeting in Honolulu.

The Gehanis are no strangers in The American Dental Association. Dr. Rekha Gehani is a practicing Orthodontist in Jackson Heights and is a Chair of Council on Dental Education and Licensure of the ADA.

"I want to thank you for putting your faith in me," Dr. Gehani told the delegates after his election. "I promise you I will always be what I have always told you I would be: your servant-leader."

Dr. Gehani, who has served as an ADA delegate from 2000-14, is the immediate past trustee of the ADA's 2nd District. He previously served as president of the New York State Dental Association in 2011, the President of QCDS in 2003 and the president of the Indian Dental Association in 1985-1987. He is also a trustee of the New York State Dental Foundation and is on the Board of Directors of the Empire Political Action Committee. In addition to the tri-partite, Dr.

Gehani is a member of the American Association of Endodontists, and a Fellow of the International College of Dentists, the American College of Dentists and the Pierre Fauchard Academy.

Dental Medicine. He is the recipient of the Ellis Island Medal of Honor, the Emil Lentchner Distinguished Service Award from QCDS, the Lifetime Achievement Award from Indian Dental Association, the Foundation of Excellence in Com-

Mexico Mission

The Queens County Dental Society teamed up with the Colgate "Bright Smiles, Bright Future Van" once again on November 7 at the Jackson Developmental Center in Jackson

Heights and on November 8 at the Jackson Developmental Center in Astoria. This event aims to provide oral screenings and promote dental hygiene to neighborhood children.

Volunteer dentists are needed for similar future events to provide oral exams and dental hygiene education. The Colgate van provides the dental equipment and supplies.

Veterans Smile Event

Established nationally by the ADA's Institute for Diversity in Leadership, the Veterans Smile Initiative is a program in which individual dentists screen and treat veterans in their office on a designated day or days on or coinciding with Veterans Day. It's a great way for the dental profession to give back to our nation's veterans by helping to alleviate the problem that many of them experience in accessing treatment. This year, the Foundation is helping volunteer organizations wishing to treat our veterans as part of Veterans Smile by providing grants. Many people don't realize it, but our veterans do not receive dental care benefits through the U.S. Department of Veterans Affairs unless they are 100-percent disabled or have service-related injuries to their mouths.

To qualify for consideration submit an application to lbleon@nysdental.org outlining your planned veterans' dental initiative; its date and location; what services will be provided; how many volunteer dentists and auxiliaries will participate; how many veterans you anticipated treating; event budget, amount of New York State Dental Foundation funding requested, and, if applicable, other funding sources; and what veterans group in your area (VFW, the American Legion, Disabled American Veterans, etc.) can help spread the word and find patients who need our help. If appropriate, a letter of support from a local public health organization or veteran's organization should be included with the application. The New York State Dental Foundation Board will consider all properly completed applications and make funding decisions. This information can be found on the website of the NYSDF.

The Third Victory

Our financial portfolio is standing well, our World's Fair of Dentistry event was a huge success. Historically, this year's event had a record-breaking number of participants. General membership meetings and video study clubs are very successful. We are heading in the right direction. The Queens County Dental Society will not increase dues locally. Dr. Blecker was born on August 27, 1941. The son of Irving and Anne Blecker, he was raised in Brooklyn and later moved to Flushing with his two younger sisters, Lynn and Michele. Following his graduation from Stuyvesant High School in 1959, Dr. Blecker attended Queens College, City University of New York, and graduated in 1963. He met the love of his life, Joann Potaznik, in October of 1962. Following his graduation from college, Dr. Blecker received his Doctor of Dental Surgery degree from New York University followed by fellowships at NYU and Coney Island Hospital. He went on to complete an oral and maxillofacial residency pro-

gram in New York City.

Dr. Blecker continued his devotion to the medical field by becoming an attending oral surgeon on staff at New York Hospital Queens. He supervised dental residents and provided lectures on various oral surgery topics. He was a member of numerous professional societies including a fellow of the American Association of Oral and Maxillofacial Surgeons, and fellow of the American College of Oral Implantology. Dr. Blecker was a member of QCDS for 36 years. He was a friend, colleague, and mentor to many dentists practicing in Queens.

An avid skier and poker player Dr. Blecker lived his life to the fullest. He traveled the world with his family seeing and embracing all that the world had to offer. Dr. Blecker was devoted to his family and his profession. The world has lost an amazing soul whose kindness was unmatched and whose heart was big enough to encompass everyone who crossed his path. Dr. Blecker will be remembered for his zest for life and ability to make anyone and everyone smile.

Dr. Blecker is survived by his daughters Allison and Meryl. He is also survived by many cousins, nephews, and grandchildren who view Dr. Blecker as the patriarch of the family.

All applicable dental practices are required to submit this form, even if they submitted the previous form, as it specifies new compliance requirements. 

Dr. Anvar's Program Brings Veterans 'A Smile,' Looking for Others to Join His ADA Initiative

Veterans' Smile Day was started several years ago as a project of the ADA's Institute for Diversity in Leadership. Dr. Deryck Pham's project caught the eye of a couple of interested dentists. Dr. Karin Irani and Dr. Bijan Anvar both got involved and became champions of the project and helped to make it a national event that now

includes over 1,000 dentists.

Dr. Anvar is proud to be a co-founder of the event. "I love the opportunity of 'serving those who served,' that's our motto," he said. "I'm also impressed by the popularity of our efforts."

Since co-founding the event, Dr. Anvar said that several other states have signed on and are participating. The New York State Dental Foundation has supported the event and has started its own initiative.

Veterans don't usually get dental coverage unless they are 100 percent disabled, leaving many veterans without dental care or a dental home. "We ask our participating dentists to do as much, or as little, as they are comfortable doing. Some practices may only be able to do exams and cleanings, while others have done more," said Dr. Anvar, "all at no charge to the patient."

Dr. Anvar has treated many veterans over the years, providing a variety of services, including exams, restorations, extractions, and root canals. "It's a small way for me to show my gratitude to those who have served."

Dr. Anvar's hope is to have every dentist participate in the event. Dentists usually see patients in their own offices and often have some supplies sent to them by Henry Schien. "Henry Schien has been a great supporter of this program. They have worked very hard to support our efforts. We get more sponsors every year, and, with their support we will continue to grow and help more and more veterans," said Dr. Anvar.

If you do have a photo, make sure it's current and a close-up. (Think about a passport photo: Include your head and shoulders — but unlike a passport photo, you can smile!) RISK MANAGEMENT ALERT



DENTAL MALPRACTICE INSURANCE UPDATE

Topic: Managing the Risks of Maxillary Molar and Premolar Extractions

Professional Advice

Maxillary molars and premolars are located in proximity to the maxillary sinus, and their extraction can result in a perforation and oral antral communication. Although rare, the potential for a fracture of the maxillary tuberosity must also be considered before initiating an upper molar extraction. To help manage the risks associated with maxillary posterior extractions, a thorough pre-operative examination should be performed, inclusive of a review of diagnostic radiographs and an updated medical history. A sober assessment must then be made regarding a referral to a specialist.

A referral should always be made to an oral surgeon if the tooth to be extracted is impacted, there is significant curvature or angulation of the roots, it is severely infected, bone appears thin, fused to roots or ankylosed, roots are in the sinus, and/or the sinus lies low. A referral should also be made if the general practitioner lacks skills necessary to perform a complex surgical extraction, and does not have immediate access to a specialist. For, it is not uncommon for a posterior maxillary tooth to appear capable of a simple extraction, but turn out to require root sectioning or significant bone removal.

As a matter of routine, practitioners recommending an extraction should document the rationale for the procedure, and note any pain complaints and symptoms. The patient chart should also reflect that informed consent was obtained and that the risks of the extraction were discussed and alternative treatment offered. At minimum, patients contemplating a maxillary molar or premolar extraction should be advised of the following risks: pain; swelling; bleeding; fracture of the tooth and/or surrounding bone; possible injury to adjacent teeth and structures; sinus perforation and complications; infection; dry socket; and the need for further treatment.

In the event of abnormal movement suggestive of a tuberosity fracture, the practitioner should immediately stop the attempted extraction and refer the patient to an oral surgeon. A referral to an oral surgeon and an ENT should also immediately follow identification of a sinus communication, or any suspicion of same.

Practice Points

Focus: Before undertaking an extraction of an upper posterior tooth, a general dentist should determine that a referral to an oral surgeon is not indicated, and that informed consent is properly obtained and documented.

✓ **DIAGNOSTIC RADIOGRAPHIC STUDIES ARE ESSENTIAL TO A PRE-OPERATIVE ASSESSMENT, and should be liberally utilized. Patients should be referred for outside testing as needed.**

✓ **IMMEDIATELY INFORM THE PATIENT IF A COMPLICATION IS ENCOUNTERED AND MAKE ALL APPROPRIATE REFERRALS.**


munity Service from the New York State Dental Foundation and the International College of Dentists Award for International Dental Service.

"I will be working hard for you. We are the leading authority of dentistry, not just in the United States, but globally," he said. "Let's work together."

Safe dental care must be provided only in a dental facility by a dental team, with a dentist as the leader of the team. Dental Society. He was born in 1916 and graduated from NYU Dental School in 1940 and completed his residency at Harlem hospital 1941.

He was called into service in the Army Air Force following completion of his residency. He joined as a captain and served as an oral surgeon. He was discharged from active duty in 1946 and was promoted to the rank of major in 1947, serving in the Armed Forces Reserves before his final honorable discharge in 1953. He was decorated with the American Campaign Medal, the World War 2 Victory Medal, and the European African Middle Eastern Campaign Medal.

As a civilian, he worked in a dental practice in Manhattan and then opened his own general practice in Rockaway Park, where he practiced for more than six decades.

Dr. Leichter married his childhood sweetheart, Blanche, and was married for almost 66 years. The couple had one son, Marc. He instilled good moral values in his son as well as his son's friends. His humanity and compassion were noted in his practice, family and community.

Two years ago, on his 100th birthday, Dr. Leichter was presented with letters of congratulations from the American Dental Association. Oleg Rabinovich, executive director of QCDS presented Dr. Leichter with a plaque that read: "The Board of Trustees of the Queens County Dental Society recognizes Dr. Moe Harris Leichter on the occasion of his 100th birthday for serving the dental needs of his patients in Queens." Dr. Leichter had been a member of the tripartite for 79 years.



