

## QCDS Past President Prabha Krishnan To Be Vice President of the State Dental Association

Queens County Dental Society Past President Dr. Prabha Krishnan, a Forest Hills periodontist since 1993, has been elected to a one-year term as vice president of the New York State Dental Association. Following the sequence of NYSDA officers, she

would become president-elect next year and president of the Dental Association in 2024.

Elected by the House of Delegates along with Dr. Krishnan were Dr. James E. Galati of Schenectady, president; Dr. Anthony Coumo of Westchester, president-elect; Dr. Frank C. Barnashuk of Buffalo, treasurer; and Dr. Steven Gounardes of Brooklyn, speaker of the House of Delegates.

"I am committed to insuring a strong future for the New York State Dental Association," Dr. Krishnan said following her election. "I want to do what I can to work with all of the components to help them improve."

The last QCDS member to head NYSDA was Dr. Chad Gehani in 2011. Dr. Gehani, who went on to become president of the American Dental Association and is now the QCDS executive director, happened to be Dr. Krishnan's professor of endodontics when she was a graduate student at the New York University College of Dentistry. He recalled her as a student "who was always very knowledgeable and very quiet. But," he said, "quietness should not be taken as a lack of understanding. She was an A-plus student."

Dr. Gehani recalled that Dr. Krishnan liked to study and work on difficult cases and always finished her assignments ahead of time. "That is the sign of a good student and a good leader," he said.

Dr. Krishnan has been attending and chief of periodontics of the Department of Dentistry at Flushing Hospital Medical Center since 1995 and has served as an associate clinical professor of the Department of Periodontics at the New York University College of Dentistry.

Dr. Krishnan had been a member of the NYSDA House of Delegates from 2010-2015 and again from 2020 to the present, a NYSDA trustee from 2015-2019, a member of the Council on Dental Benefits from 2019 to the present, the Council on Governmental Affairs from 2009-2015 and she served as the chair of the Council from 2012-2014, the Council on Membership from 2000-2009, and a member of the NYSDA House of Delegates Reference Committee in 2014.

Also active in the American Dental Association, Dr. Krishnan serves as the vice chair of its Council on Communications. She was also a member of the Diversity and Inclusion Committee of the ADA Board. Dr. Krishnan was an ADA delegate from 2010-2015.

At QCDS, Dr. Krishnan was president in 2009. She has served as the chair of several Councils of QCDS.

She is a member of the Board of Directors of the Empire Dental Political Action Committee and the Board of Trustees of the Indian Dental Association. She has been a trustee of the New York State Dental Foundation since 2019 and has chaired its Annual Event Task Force since becoming a trustee.

"I really enjoy what I do," Dr. Krishnan said. "I want to make a difference in the profession and give back to it and the community in appreciation for all that it has done for me."





# QCDS Comes to the Aid of Queens Dentist Who Loses His Home to Devastating Fire

South Ozone Park dentist Dr. Salvador Gales lost his Roslyn Heights home to a fire in June, but the Queens County Dental Society was there to give him assistance in his time of need.


QCDS Executive Director Dr. Chad Gehani visited him after the devastating fire, bringing him a check for \$2,500 from the organization as a token of support. "We wanted to let Dr. Gales know that his professional brothers and sisters have his back," Dr. Gehani said. "Our Board wanted to present a symbol of love and support to a loyal member."

Dr. Gales said the fire started on a backyard deck and quickly consumed the entire two floors of the single-family house. Although his wife was able to

escape unhurt, the family's two dogs were lost in the blaze. Dr. Gales was not home at the time of the fire. The cause of the fire is currently being investigated and the family has been living in a nearby rented house for the past two months.

"I am very thankful for the support I have received from QCDS," Dr. Gales said. "The financial assistance I received from the Dental Society may not seem like big money, but it was certainly big money for us."

Dr. Gehani said Dr. Gales was always a devoted QCDS member and among the first to register for events. "Our message should be clear," he said. "QCDS stands behind our members in any way we can."



# Keep Permits Current To Avoid Penalties

By now all dental facilities should have their permits up to date. Some dentists who are several years behind have received summonses by mail. To renew a permit, you will need to submit a signed renewal application, proof of disability insurance and proof of worker's compensation insurance. Be aware that you must use specific form numbers and include a copy of the summary page of your last CRESO inspection, within five years of renewal date. A check for \$100 must be included for every two years being requested dated from the last expiration day. If you do this online, you can only buy two years at a time, and then renew again until you are up-to-date. If you do this by mail, you can buy back two or three time periods at a time.

To renew by mail, request a renewal application by calling 212-487-4060. Send it to Licensing Bureau, 42 Broadway, 5th floor, New York, NY 10004.

To renew online, go to Google and type in [nyc.gov/health-permits](http://nyc.gov/health-permits), hit enter and scroll down until you see "Renew Most Permits." Needed is your PIN number, which was assigned by the New York City Department of Consumer Affairs. If you are like most dentists, you ignored this number and will need to retrieve it or get a new PIN number. To apply for a new PIN number, go on Google to [www1.nyc.gov/assets/doh/acceladohmh](http://www1.nyc.gov/assets/doh/acceladohmh) and click on the site that reads "Accela Contact Us Form - NYC.gov" to fill out the form. You will still need to submit the above items by scanning or attaching emails to renew. A handy number for assistance is 347-396-7975.

New permit should only take three to four weeks to arrive. If yours is not received, call 212-487-4060 to inquire. This is not the procedure for a new permit or for a change of ownership or address. If you owe the New York money for a fine, you can be denied a renewal.

Remember that dental inspections are every five years. Permits are every two years. CBCT requires its own separate permit and annual calibration with semi-annual tests.



## Clinical Case Example

Tooth #15, set to be extracted.



Remove the entire pathologic periodontal ligament and flush socket twice. Use #6 carbide bur, make holes through the Lamina Dura to trabecular bone and establish Regional Acceleratory Phenomenon.



Insert Large or Slim sized OsteoGen® Bone Grafting Plugs and allow blood to absorb.



Two Slim OsteoGen® Plugs are in place. Suture over top of socket to contain Plug. Do not suture through Plug. No membrane is required.



OsteoGen® is a low density bone graft and the OsteoGen® Plugs will show radiolucent on the day of placement.




As the OsteoGen® crystals are resorbed and replaced by host bone, the site will become radiopaque.



The collagen promotes keratinized soft tissue coverage while the OsteoGen® crystals resorb to form solid bone. In this image, a core sample was retrieved.



Implant is placed. Note the histology showing mature osteocytes in lamellar bone formation. Some of the larger OsteoGen® crystals and clusters are slowly resorbing. Bioactivity is demonstrated by the high bone to crystal contact, absent of any fibrous tissue encapsulation.
